INFRASTRUCTURE

Southeast Michigan's prosperity depends on modern and well-maintained infrastructure. Our means of transportation are evolving, and our dependence on communications technology is expanding exponentially. There is a critical need to continue safe and affordable water delivery to residents while minimizing threats to homes and businesses from extreme weather events and flooding. Funding and management of vital shared and local infrastructure assets are foundational to shared prosperity and economic development.

GENERAL

- Prioritize funding for projects that integrate roadway improvements with additional underground infrastructure projects.
- 2 Support legislation to enable public-private partnerships (P3) to fund public infrastructure projects
- Prioritize infrastructure investments based on the needs of older regions to enhance quality of life and address future needs, especially in underinvested communities.
- 4 Ensure that federal and state infrastructure funding supports training for quality, sustainable careers.

TRANSPORTATION

- Modernize the funding system with a more diversified revenue base and equitable funding approaches, including evaluation of existing formula-based funding (eg. Act 51, surface transportation reauthorization).
- 6 Promote public/private investment in infrastructure to grow the mobility industry.
- 7 Provide federal resources to states with major international trade corridors.
- 8 Support enhanced regional transit, including increased federal, state, and private investment in public transit.
- 9 Promote efficient freight movement through a multi-modal transportation program.
- 10 Improve traffic safety for all users, including road workers, bicyclists, and pedestrians.
- 11 Promote programs and policies to improve safety and reduce distracted driving.

	WATER
12	Increase funding for the Clean Water and Drinking Water State Revolving Funds: especially to deal with lead and PFAS needs.
13	Support increased resources across all types of water infrastructure based on regional and local priorities through grants 13 or programs such as the Drinking Water State Revolving Fund (DWSRF) and the Sewer Revolving Fund (SRF) to assist in dealing with emerging water issues.
14	Support long-term funding options including stormwater utilities.
15	Support state and federal resources for water affordability programs, including creation of a statewide, sustainable, 15 water assistance fund with stringent qualifying requirements for customers and flexibility for utilities without mandating participation.
16	Prevent and address/eradicate threats such as invasive species and nutrients (fertilizer/untreated sewer discharge).
	WATER & SEWER INFRASTRUCTURE
17	Expand WIFIA (Water Infrastructure Finance and Innovation Act) that establishes a financing mechanism for water and wastewater infrastructure projects.
	ENERGY
18	Support energy policies (such as EV charging infrastructure and grid modernization) that balance reliable and affordable energy with environmental benefits of renewable, clean and sustainable energy options.
	BROADBAND
19	Respect the responsibility of local governments to manage use of the public right-of way and utility easements
20	Support the full deployment of affordable high-speed broadband, especially in rural and underserved areas to ensure access education, healthcare, and other critical services

ECONOMIC DEVELOPMENT

Economic development is reliant on state and local policies, regulations, and permit processes that facilitate a robust business climate while providing environmental and worker protections. Policies and incentives should focus on placemaking and community investment that benefits residents, workers, and businesses of all sizes.

HEALTHCARE

As an issue of regional and national importance, access to equitable and quality healthcare requires additional resources and flexible service delivery, including enhanced use of technology. The ability of service providers to attract and retain a diverse and skilled workforce is essential to improving health outcomes for all.

42	Ensure that long-term federal Medicaid funding is not reduced below 90% and that any future funding formulas or serviced delivery criteria do not disadvantage Michigan, so that the Medicaid program can continue to provide needed services to Michigan residents.
43	Ensure that states maintain a strong role in oversight of health care plans, best practices, and standards for efficiency and quality of care.
44	Protect the availability of existing financing mechanisms for state Medicaid programs, such as provider taxes.
45	Promote partnerships with law enforcement and the mental health community to improve handling individuals with behavioral health disorders.
46	Fund and improve availability of mobile health clinics and community outreach professionals in disadvantaged communities to increase access to essential services.
47	Strengthen retention of healthcare workers by addressing staffing levels, resources, safety concerns, working environment, and other workplace conditions leading to higher turnover and professionals leaving the healthcare industry.
48	Support the healthcare industry by providing resources for programs to attract, train, and reskill workers to assure high quality patient outcomes.

EDUCATION

Education institutions rely on strong state and federal partners to provide access to adequate and flexible funding to ensure a welleducated and trained workforce. Future-proofing students and learners by preparing them for a rapidly changing economy through education, training, and experiential learning will ensure success in the workplace and support the region's economy.

53	Expand and strengthen the career guidance system (such as increasing the availability of career counselors and career navigators) to promote technical education, career exposure, and career pathways at secondary and post-secondary levels.
54	Provide adequate resources to ensure student safety.
55	Invest in early childhood education and quality child care services.
56	Develop a robust educator pipeline through fair compensation as well as promoting recruitment and retention, and alternative pathways.
57	Require all publicly funded schools to follow the same regulations and requirements for accountability and transparency.
58	Continue efforts to support all public schools, including the Detroit Public Schools Community District.
59	Incorporate digital skills, life skills, and workplace skills into K-12 curriculum.
60	Support child nutrition funding to allow for no-cost school meals for all K-12 students.
61	Encourage student interest in high-demand and knowledge-based careers by funding and promoting experiential learning initiatives, including paid work-based learning through industry/education partnerships, at K-12 and higher education levels.
62	Ensure that every child has equal access to educational materials and technology – including adequate high-speed broadband service – inside the classroom and where they reside, to enable students to achieve their highest potential.

Guarding homes, businesses, and infrastructure against extreme weather and flooding is imperative.
